TERMS OF USE

A. INTRODUCTION

These Terms of Use set forth the rules and conditions for the use of the Eczacıbaşı Momentum Website ("**Momentum**" or "**Site**") and regulate the rights and obligations of the Parties accordingly.

Access to the Site, use of the Site and any transactions to be performed by Users on the Site are subject to these Terms of Use.

You hereby agree to the Terms of Use by using this Site. You hereby declare that by accepting the Terms of Use, you have all the legal permissions and requirements necessary to use the Site and accept the Terms of Use, and if you will use the Site on behalf of a company of which you are an authorized representative, you have all the necessary authorizations to represent the company in question and to carry out transactions on behalf of the company.

THE COMPANY PROVIDES NO WARRANTIES OR CONDITIONS OF ANY KIND, EXPRESS, IMPLIED, STATUTORY OR OTHERWISE, INCLUDING ANY WARRANTIES OR CONDITIONS OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, IN CONNECTION WITH THESE TERMS OF USE. THE COMPANY PROVIDES NO WARRANTIES THAT THE MOBILE SITE WILL BE ERROR-FREE OR UNINTERRUPTED (INCLUDING IN THE EVENT OF CYBER-ATTACKS OR MALICIOUS CODE OR SOFTWARE DISRUPTIONS) OR COMPATIBLE WITH ANY TYPE OF SOFTWARE. THE COMPANY DISMISSES LIABILITY FOR ANY DAMAGES ARISING OUT OF YOUR ACCESS TO OR USE OF THE MOBILE SITE.
